#### **New Phone Books Arrive**

Local folks who need additional directories are encouraged to pick them up at one of these locations in order to save on the high cost of postage. We will continue to mail directories to anyone out of the area or to home-bound customers.



#### 20<sup>th</sup> Annual Golf Tournament Raises \$20,800 for VFDs

Thirteen volunteer fire departments were honored at Colorado Valley Communications (CVC) on October 1<sup>st</sup>, when employees presented them with \$20,800.

The donation was comprised of the profits from the 20<sup>th</sup> Annual Hotter Than Heck Employee Sponsored Charity Golf Tournament and the CVC Employee Charity Fund. Employees raised \$18,651 through sponsorships of the tournament. An additional \$2,149 was provided from the employee charity fund, which is collected through voluntary payroll contributions. The combination of these two resources allowed each of the 13 fire departments to receive a check in the amount of \$1,600.

This was the 15<sup>th</sup> year that the fire departments were chosen as the recipients of the profits from the golf tournament.
